Call to Order

• The December 12th meeting of the NERAC Council was called to order by Chief Jason Gilliland at 1:00pm. He asked for approval of the November 14th, 2019 meeting.

EOPSS

- V. Mboka-Boyer provided an update on behalf of EOPSS:
 - Engrid Backstrom has passed her background check.

MAPC

 - \circ MAPC submitted phase II of the SPR/THIRA to EOPSS last week on December 6th.
 - The December newsletter is ready to be distributed, the Council was provided with copies.

FFY17/FFY18 Budget Update

- C. Graham provided a budget update for FFY17 and FFY18.
- Each Council member was provided with copies of the FFY17 and FFY18 budgets.
- The FFY17 grant has closed out, moving forward projects will be working off the FFY18 budget.

Project Updates

Regional Communications Center Shelter

- The shelter installation has been completed onsite.
- The fencing installation around the shelter is still being completed.

Bleeding Control Kits for Schools

- Two distribution events have been held so far, one in Beverly and one in Framingham.
- To date, 21 districts have picked up their kits, totally 372 kits.



• The next distribution event will take place on December 17th at the Westford Fire Department.

Cybersecurity Update

- 14 NERAC municipalities submitted a letter of interest for the cybersecurity risk assessment initiative.
- MAPC sent out an additional form to those 14 municipalities that the vendor provided to obtain more specific information about the municipalities' IT networks.
- 7 municipalities submitted the additional information form to MAPC.
- The communities interested are Arlington, Burlington, Chelmsford, Rowley, Wakefield, Watertown, and Wilmington.
- The vendor is working on sending NERAC a quote for the risk assessment, once the pricing is received the Council will need to choose the communities to be assessed.

Website Renewal

- The NERAC website hosting service expires this month. In order to continue running the website, the Council will need to allocate funding to renew the hosting service.
- The fee for the year is \$1,510.80.
- The funds for this project can be taken from the additional FFY18 funds (\$39,692.26) that will be received from EOPSS, which will be available shortly.

He has contributed expertise to a variety of public health, evacuation, and sheltering-related projects, such as the purchase and maintenance of inflatable shelter systems.
