EOPSS/MAPC Updates

EOPSS

- V. Mboka-Boyer provided the following updates on behalf of EOPSS/OGR:
 - The FFY19 contract has been extended to the end of the year (12/31/21) instead of the previous deadline of July 31^{st} .
 - The FFY21 Notice of Funding Opportunity (NOFO) for the SHSP grant is expected by the end of February.
 - The Commonwealth has allocated \$950,000.00 for the Non-Profit Security Grant, with the notice of funding scheduled to be posted on the EOPSS website by the end of the day (2/11).

MAPC

- A. Murray provided the following updates for MAPC:
 - MAPC will be sending confirmation messages to individuals who had projects approved as part of the FFY20 Plan.
 - A. Murray introduced Glenn Carrano, who is the region's new Protective Security Advisor from the Cybersecurity and Infrastructure Security Agency (CISA).

FFY18/FFY19/FFY20 Budget Updates

- Budget updates were provided to all Council members, including the FFY20 grant for the first time.
- The awarded amount for FFY20 is \$0.11 over the amount included in NERAC's FFY20 Plan.

Project Updates

Portable Ventilators

- The last remaining three ventilators owed to the North Shore Medical Center have been shipped by the manufacturer, and should be delivered to the distributer later this week.
- The five air oxygen entrainment mixers that were meant to be included in the original shipment of ventilators (to Lawrence General, Lowell General, and Anna Jaques) were meant to be delivered to the distributer on Tuesday 2/9. They will be exchanged with oxygen reservoirs in the coming days.

Medical PPE Cache

- J. Brickett presented an alternate site for the NERAC medical PPE cache. The Beverly cache site had informed MAPC and NEEMS that it was unable to accept the terms of the MOU needed to establish the cache.
- The new location would be the same complex as the Northeast EMS offices, with a monthly fee associated with renting the space, between \$125 and \$175 per month.
- The Council discussed the two sites and ultimately decided that the cache should be established in Beverly, with J. Brickett willing to act as the main cache manager and POC for borrowing communities.
- MAPC will conduct the procurement for PPE once a location is finalized and the MOU has been signed by all parties.

Essex County Fire Portable Radios

- The project to purchase portable APX8000 radios for the Essex County Fire Chiefs Association was approved by the SIEC at its February meeting.
- MAPC will conduct a procurement for the purchase of 12 radios once specifications are confirmed by project stakeholders.

Burlington Mall Full-Scale Exercise

• MAPC submitted the ERR for the exercise to EOPSS on Tuesday, February 9th.

- An EHP will be submitted shortly.
- After the EHP is approved by FEMA, MAPC will conduct a procurement for a consultant to manage the planning and facilitation of the full-scale exercise.

Chelmsford Trailer Exterior Lighting

• The RFQ for the Chelmsford trailer lighting came in \$840.00 over budget.

Outreach to Regional Stakeholders

- MAPC will again send and application form to all Police/Fire Chiefs, EMDs, Town Administrators, etc. and will post the materials on the website and social media outlets.
- The Council confirmed the following conditions for applying for NERAC funding in

FFY21:

- Requests for over \$15,000.00 may be required to be made in person.
- All recipients must be able to demonstrate that their radios are programmed with the MA Tactical Channel Plan, to the extent possible.

Committee/Working Group Updates

Training & Exercise

• The Training and Exercise Committee did not meet in February.

Interoperability/Info Sharing

- C. Ryan provided the following update:
 - The NERAC Interoperability Committee met on Tuesday, February 9th.
 - The projects to purchase portable APX8000 radios for the Essex County Fire Chiefs Association and the District 5/15 Simulcast equipment were approved by the SIEC at its February meeting.
 - Additional funds were transferred from the Field Communications Unit Upgrade project to the FD 5/15 Simulcast project.
 - The Committee spoke to Chief Frizzell from MetroFire, and will consider funding those projects that were on the "B" List in FFY20 in FFY21.

Regional Equipment Cache

- A. Murray provided an update:
 - Cache fees are still frozen while FEMA completes its review of the Regional Cache Program.
 - MAPC is working with Beverly to determine if cache fees can be connected to grant years, and to determine an exact cache account balance.

Evacuation/Sheltering

- J. Costanzo provided an update:
 - Next month MAPC will provide an evacuation planning guide to the Council for review, and will be posted to the NERAC website.

Hospitals

- B. Klag provided an update:
 - Hospital numbers continue to go down but still exist.

Mobile NERAC App

- MAPC reminded Council members that six months ago, the Council approved a continuation of services for the NERAC mobile app.
- After a redesign and changing vendors, the plans on the app have only been downloaded 15-20 times in that span. The service will run out at the end of the month, and it is \$666.67 per month to keep the app online.
- Now that the NERAC website has also been redesigned, the app may be redundant. The Cache Fee Table, contact information for each site, etc. is now easily accessible online.
