• Heidi Murphy Green, FBI Crisis Management Specialist, presented on FBI topics.

Budget Updates

- Committee members were provided with copies of the FFY19, FFY20, and FFY21 budgets in the meeting packet.
 - o FFY19 Grant End Date: Dec 31, 2022
 - The two main line items with remaining funding are A.14 (ECFCA UHF) which is in the middle of procurement, and I.01 (NEMLEC SWAT Radios) which has a PO issued, and just waiting on delivery.
 - o FFY20 Grant End Date: June 30, 2023
 - o FFY21 Grant End Date: July 31, 2023

Project Updates

- NEMLEC SWAT Radios
 - The PO was issued on June 9. Motorola has not yet been able to give a ship date estimate, but I will continue to follow up.
- Merrimack Valley Camera System Expansion
 - The EHP is drafted and with Chief Vasque of Lawrence PD for review to confirm the coordinates and pictures of all 24 poles for the cameras are accurate and answer a few remaining questions.
 - Next, we will obtain letters of permission from the Chief Municipal Officers of each community where the cameras will be installed.
- Statewide CISO Project
 - This was a joint project among all 4 HLS regions, which hired a consultant team to conduct a study of the feasibility of installing Regional Chief Information Security Officers across the Commonwealth to support cybersecurity improvements at the municipal level.
 - o The project began with a kick-off meeting in December 2021, and continued with bi-weekly

- project update meetings as the consultant conducted research and interviews to develop their findings.
- o The consultant held a presentation of the report for the planning team on July 20.
- o NERAC cybersecurity experts, E. Chao/C. Cousens presented a summary of the findings and recommendations to the Council.

NERAC Ambubus

Pro EMS concluded that the Ambubus was unsuitable for their needs and is no longer interested.
Chief Gilliland reached out to his contact at Cataldo Ambulance, they saw the Ambubus stored at
MVRTA, and are interested. A new MOU is being drafted for their review and discussion. A
meeting will be scheduled with Cataldo representatives next week.

Hudson Foam Trailer

- During the June meeting, the Council voted to investigate costs on how to remediate the problem of the NERAC foam trailer housed at Hudson FD.
- The direction we received from EOPSS is that HSGP funds cannot be used for remediation of PFAS, and this position is not expected to change.
- Since firefighting is a core capability and the need for a fuel firefighting capability is critical to HLS response, EOPSS:OGR would consider a project proposal for replacement "green" firefighting foam if scaled and scoped in proportionate amounts for regional response.

Committee/Working Group Updates

- Training & Exercise Chief J. Gilliland
 - o The ADLS course took place in June.
 - Leftover funding from the Stop the Bleed training project was unallocated for new or current projects.
 - o Burlington Mall FSE After Action Report was approved by EOPSS
 - Both ATIRC and LASER courses took place in June and July. Both courses received positive feedback.
 - o Both the Topsfield School Evacuation FSE and the Domestic Water Supply TTX After Action Reports were presented and approved by the Committee.
 - o For the FD-14 Tech Rescue Team, one AAR and three ERRs were approved.
 - The Northeast Tech Rescue Team updated the Committee that their two upcoming drills have been pushed back a month.
- Interoperability/Info Sharing C. Ryan
 - o The Littleton All Band Radio project came in over budget, so the Committee allocated additional funding.
- Regional Equipment Cache M. Collins
 - o Most of the Lexington cache equipment has been moved to the Beverly site. At upcoming meetings, the Committee will discuss administrative issues, specifically the MOUs.
 - The FBI also came to visit the cache site in July and are now aware of the full scope of NERAC's cache resources.
- Evacuation/Sheltering No report, on break until the Fall.
- Discussion of Potential Technology Committee

 Chief J. Gilliland
 - M. Foster requested to discuss creating a Technology Committee. The Council believes that there may not be a need for this Committee since there are two cyber experts on the Council.

Discipline & State Agency Liaison Updates

- Discipline Updates:
 - Cybersecurity- E. Chao and C. Cousens are meeting with Tufts University to discuss their interest in NERAC's FFY22 cyber internship program.
 - Emergency Medical Services- There are new protocols on transporting

- police dogs injured in the line of duty to hospitals.
- Public Schools- Marblehead will be engaging with police and fire departments across towns next week at a meeting.
- State Agency Liaison Updates
 - Massachusetts Emergency Management Agency- There will be upcoming in person trainings (e.g. Emergency Management Directors, ICS courses). The NEPG Grant will be open in another month.
